
Emerging Orthotic Management Concepts in Neuro-Rehabilitation

Toddlers and children with movement and posture disorders can benefit from orthotic solutions that are both individual to the patient's current presentation and that consider emerging concepts in neuro recovery (including concepts for improving range of motion and gait). This course demonstrates how the upper and lower extremity orthotic process is instrumental in determining the appropriate brace design. This process includes evaluation of R1 and R2, observation of gait and standing alignment, evaluation of isolated and bimanual upper extremity movements, consideration of treatment goals. incorporation in patient domains, and compliance. In addition to evaluation, this course will review emerging orthotic concepts and will demonstrate these concepts through a live patient lab. Careful consideration will be given to each member of the rehab team's role in the treatment process and the final orthotic solution.
